Terms and Conditions

1. The Promoter is Australian Radio Network (GOLD104.3) ABN 32 067 769 466, Level 2, 21-31 Goodwood Street, Richmond, 3121.
2. The Radio Station is GOLD104.3FM.
3. Information on how to enter and prizes forms part of these terms and conditions. Any general competition rules or terms and conditions of the Radio Station do not apply to this Promotion.
4. Any entry which does not comply with these terms and conditions is invalid.
5. Entry is open to residents of Victoria. Employees of the Promoter or its associated companies, employees of any agencies, affiliates, sponsors, sub-sponsors or representatives of the Promoter and the immediate families of any such employees are not eligible to enter. Any person who has won a prize valued at \$1,000 or more from the Promoter, or the Radio Station, in any promotion within the past six months, is ineligible to enter.
